

General terms and conditions for the Waldseilgarten Oberreith

We are happy to welcome you in our Waldseilgarten and hope you will enjoy it here!

1. The usage of the high ropes course is only allowed after reading and acknowledging these terms and conditions by signature. Children and adolescents under 18 years of age may only climb with the written consent of a parent, supervising adult or legal guardian.
2. Participants are asked to appreciate that the use of the Waldseilgarten Oberreith is associated with risks. Participants use the park at their own risk. Employees or other auxiliary persons are not liable unless the damage is a direct result of their negligence or misconduct. The operator of the high ropes course does not take any responsibility for damage on the participants clothing or personal belongings. All accidents or damage to personal property must be reported to staff immediately.
3. The equipment and courses in our high ropes course may only be used by persons with a minimum height of at least 1,10 m. Individual parts of the high ropes course are especially designed for children under the height of 1,30 m. After consultation with one of our staff, children under the height of 1,30 m can be allowed on some of the higher courses but must be accompanied by an adult at all times.
4. Participants of the high ropes course may not be under the influence of alcohol, drugs or medication that might impair their physical or mental capabilities. People who suffer from physical or psychological conditions that may prove to be a danger to themselves or others in the Waldseilgarten Oberreith may not climb in the interests of their own and others' safety. Pregnant women after the 4th month of pregnancy may not climb in the high ropes course.
5. Participants may not take any loose items (mobile phones, cigarette lighters, cameras, etc.). into the climbing courses. Long hair must be tied back. All jewelry must be removed as well as any items where there is a danger of snagging (earrings, scarves, rings, etc.). Shoes have to be closed at the toes and need to have a tight fit.
6. Visitors are asked to assume responsibility for looking after their own personal belongings. The Waldseilgarten Oberreith accepts no liability for loss, damage or theft of any participant's personal belongings.
7. Before using the Waldseilgarten Oberreith, each participant must read our general terms and conditions and have participated in a safety briefing. For the entire duration of your stay at the high ropes course all participants must strictly adhere to and follow any and all decisions and instructions made by our staff. Any participant failing to do so will be excluded from climbing. We reserve the right to claim compensation for such behavior and the entrance fee will not be refunded. All visitors must behave appropriately whilst on the premises.
8. Only equipment (harness, helmet, safety hooks etc.) provided by the Waldseilgarten Oberreith may be used in the park. Participants are not permitted to remove or put on equipment without the supervision of our trained staff. The provided equipment has to be returned as soon as the time limit of 3 hours is over. If the equipment is returned later than that an additional fee of 5,00€ per every 30 minutes has to be paid. Any damage to the equipment has to be reported to staff immediately.
9. Elements between platforms may only be climbed by one individual at a time. A maximum of 3 people may stand on a platform at any time. Before using the Flying Fox the participant has to ensure that no other person is located in the landing area.
10. The participants in the high ropes course must always be secured with at least one safety carabiner on the safety rope (rope is marked with a green plastic at the beginning of every exercise). Deliberately unhooking both safety carabiners is not allowed.
11. The Wildpark Oberreith GmbH & Co. KG is liable according to the legal regulations for personal injury. For damage to personal property the operator is only liable by intent or gross negligence of the organizer or persons entrusted with the performance of the event.
12. The operator of the high ropes course or their representative are allowed to exclude any participant from the high ropes course that does not adhere to follow the instructions made by our staff. The Waldseilgarten Oberreith reserves the right to halt any and all activities and to evacuate the high ropes course for safety reasons (e.g. fire, storm, heavy rain). In such cases, entrance fees will not be refunded.
